## Restore the North Shore of Flathead Lake

*Group Plans Gala Art Event in Bigfork, July 29*

July 21, 2016

Dear Friend!:

How much do you value the natural beauty of Flathead Lake? We're betting you value Flathead Lake quite a lot. ***We'd like to invite you to a fundraiser on Friday, July 29, in Bigfork, to help defend Flathead Lake.*** (Click [here](#) to see invitation.)

The Community Association for North Shore Conservation ([CANSC](#)) is working to restore the north shore of the lake after the Flathead County Commissioners permitted a private bridge to be built to "Dockstader Island" that is longer than Kerr Dam! *Headwaters Montana* is acting as fiscal agent for CANSC.

Recently, the media has reported that the bridge has been "completed." On or before August 15, Flathead District Court will rule on the validity of the permit that allowed the bridge to be built in the first place. *This ruling will determine fundamentally whether Montana's Lakeshore Protection Act provides meaningful protection for any lake anywhere in Montana.*

CANSC brought the lawsuit. Suing the County isn't a trivial matter. It's expensive, time consuming, and risky. CANSC did so because

the County flatly failed to follow its own rules, and it cut the public out of an important decision affecting spectacular Flathead Lake.

The Montana Legislature passed the Montana Lakeshore Protection Act in 1975. Republican legislator Bob Brown of Whitefish sponsored the legislation. The Act intends to protect the scenic and natural values of Montana's beautiful lakes. **Without this act, no protections would necessarily exist for any Montana lake.** It's the public's one tool to check unwise development that would harm our scenic and extremely valuable lakes.
